

## RULES AND REGULATIONS

1. Name of the society : Vijaya Institute of Technology  
For Women Alumni Association (VITWAA).

2. Registered Office : Vijaya Institute of Technology  
For Women Campus, Enikepadu, 0110-13-68  
Vijayawada-521108  
Andhra Pradesh.

3. **Membership:**

VITWAA shall have the following categories of members.

- i) Life members.
- ii) Associate members.
- iii) Honorary members.

**Life Members:**

The following individuals shall be eligible for enrolment as life members of VITWAA:

Those who receive a Degree on successful completion of various full-time or part-time courses offered by VITW- like, B.Tech, MBA Such of those persons who desire to join in the association as member shall apply for membership with duly filled in and signed by the applicant and shall be sent to the secretary along with the membership fee.

**Associate members:**

Students who have studied at least one year in the institute shall be eligible to be Associate members.

**Honorary members:**

Apart from the individuals mentioned in the following individuals may be granted Honorary Membership of the Association for a period decided by the Executive Committee:

- i) Persons who have rendered distinguished service to the cause of Technical Education.
- ii) Persons who have exhibited Excellence in Industries / R&D organizations.
- iii) Persons who have contributed to social causes or philanthropists.
- iv) Heads and all the faculty members who are not the alumni of the institute shall be honorary members of the VITWAA till such time they hold their offices.
- v) Immediate past President and Secretary of the VITWAA.

All members mentioned in 5.1 shall have the right to vote, propose, second or be a candidate for any office open for election in the Association.

The members mentioned in 5.2 and 5.3 shall not have any voting rights and cannot contest in the election for office bearers.

**Membership fee:**

The eligible individuals mentioned shall grant the membership of the Association on submission of application form and payment of prescribed fee of Rs. 1000.00.

**4. PATRONS**

The President, Sri B.S. Appa Rao and Secretary, B.S.SriKrishna, SRK Foundation, Enikepadu shall be the patrons of VITWAA.

**5. GENERAL BODY MEETING:**

The Annual General Body Meeting (AGM) of the Association shall be generally held at least once in a year within nine months of the close of its accounts, preferably in the last week of January at VITWAA, Enikepadu.

Agenda for AGM shall be drawn by the Executive Committee.

Agenda for AGM inter alia shall include:

- i) Adoption of Executive Committee's Report on various activities.
- ii) Presentation and adoption of Accounts.
- iii) Appointment of Auditor.
- iv) Election of Office Bearers.

Quorum for the General Body meeting shall have minimum of 50 members.

A special General Body meeting may be convened at the instance of the President or the Executive Committee or by giving request in writing to the Secretary signed by at least 20 members who may give notice in writing to the Secretary. The quorum for the special General Body Meeting shall have minimum of 1/3rd of the members.

A minimum of 21 days of notice shall be given for AGM and of 7 days for special General Body meetings.

**6. GENERAL BODY AND ITS FUNCTIONS:**

The Administration of the VITWAA shall be managed by an Executive Committee with the following composition.

- i) Honorary President - Principal is the Ex-officio Honorary President.
- ii) President (Elected).
- iii) Vice-President (Elected).
- iv) Secretary (Elected).
- v) Two Joint Secretaries (Elected).
- vi) Treasurer (Elected among Alumni working as faculty in VITW).
- vii) Technical Advisor (Elected).
- viii) Technical Coordinator (Elected).
- ix) The executive committee shall have the freedom to co-opt the members from time to time for the efficient functioning of VITWAA. The quorum of the Executive Body meetings shall be **2/3rd of the members**.

**7. Election and Nominations :**

The elected positions will be filled through election in the Annual General Body Meeting. The elected office bearers of the Association shall hold the office for a period of 3 years.

Duties of the Executive Committee:

- i) To manage the day-to-day activities of the Association.
- ii) To prescribe detailed guidelines/rules and regulations for carrying out various activities.
- iii) To ensure continuous communication amongst the members.
- iv) To constitute sub-committees and delegate powers for specific purposes for specified period.
- v) To be in charge of and protect the properties of VITWAA.
- vi) To maintain the accounts of SRKAA and to arrange for auditing the accounts.

**8. DUTIES OF THE OFFICE BEARERS:**

**Patron**

Shall advise the executive committee regarding the smooth and efficient functioning of VITWAA.

Shall decide about any unresolved dispute(s) and the decision of patrons, shall be final and binding on executive committee and general body of VITWAA.

**Ex-Officio Honorary President**

The Principal of the Vijaya Institute of Technology For Women, Enikepadu shall be the Ex-Officio Honorary President of the Association and shall give timely advice to the VITWAA and monitor the activities of VITWAA. Shall operate the bank accounts of VITWAA jointly with Treasurer.

### **President**

Shall preside over all the Meetings. He may allocate suitable responsibilities to the members. He shall guide, conduct and up-keep the dignity and status of the Association. He has power to call for any meeting of the Association Suo Moto or through the General Secretary.

May appoint groups, sub-committees, etc., and nominate representatives of VITWAA on vacancies, Government/Institutes and/or other bodies when invited to do so.

Shall act on behalf of Executive Committee of VITWAA.

### **Vice-President**

The Board or the President may assign any responsibility to Vice President.

In the absence of President, Vice President shall preside over meetings of the General Body and the Board and exercise all powers of the President. Vice President shall also discharge the duties of the President during his absence.

### **Secretary**

The Secretary shall attend to the day-to-day correspondence and communications to and from VITWAA. He shall be in charge of all the correspondence.

He/She shall maintain official records of VITWAA.

He/She be an ex-officio member of all the Sub Committees in consultation with the President.

He/She shall be responsible for calling Meetings of the Executive Committee in consultation with the President.

He/She shall be responsible for filing of Annual Reports of VITWAA with the Registrar of Societies after every Annual and other Special General Body Meetings, Financial Statements with the Income Tax Officer, and such other statutory requirements and also maintain the minutes of the meeting.

### **Joint Secretary**

The Joint Secretaries shall assist the Secretary in discharging his duties.

They shall carry out such other duties as may be assigned to them from time to time by the Executive Committee.

One of the Joint Secretaries nominated by the President shall assume charge as Secretary in the absence of the Secretary or when requested to do so by the Executive Committee.

### **Treasurer**

The Vijaya Institute of Technology For Women Account section shall maintain the accounts and all the financial transactions of VITWAA under the supervision of Treasurer. He/She shall sign all cheques jointly with the Honorary President (Principal) and supervise the financial transactions of VITWAA.

College Account Section shall be responsible for maintaining the cash book, general ledger and other records related to finance and getting the audited statements of VITWAA prepared for presentation at the Annual General Body Meetings and file the same with the Income Tax authorities when duly passed by the General Body.

### **Executive Members**

The Executive Committee Members has to do the duties entrusted to them from time to time as per the occasion demands.

## **9. FUNDS :**

The membership fees, other contributions from the members, donations, sponsorships from external agencies, proceeds from various activities etc. shall constitute the income of the Association.

The Executive Committee shall have the power to decide from time to time the membership fees to be collected from the new members.

The funds of the Association shall be maintained in a separate bank account in the name of the "VITW Alumni Association"(VITWAA).The bank account shall be operated by the Honorary President (Principal) jointly with the Treasurer.

The Executive Committee shall have the power to invest excess funds available in the bank account in bank fixed deposits for appropriate maturities. However, the funds of the Association shall not be used for investments in any other forms like bonds, shares, gold etc.

The financial year of the Association shall be from April 1 to March 31 of the succeeding year.

**10. AUDIT:**

The appointment of a Chartered Accountant shall be made by the General Body Meeting. The period of such appointment shall be for 1 year. The auditor is required to submit the report to the President within eight weeks from the last date of the financial year.

**11. AMENDMENTS**

All members mentioned in membership are eligible to propose amendments to the Constitution of the Association. Members desirous of proposing amendments are required to submit the same in writing to the Executive Committee at least 21 days prior to the Annual General Body Meeting.

The amendments shall be passed, only if two-thirds of the members present in the AGM support the amendment(s) in voting.

**12. WINDING UP**

In the event of dissolution or winding up of VITWAA, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Executive Committee/General Body of VITWAA, but the same shall be transferred to VITW, Enikepadu-521108.

**13. DISPUTES :**

All unresolved dispute shall be referred to patrons and their decision shall be final and binding on all parties. In case of any further unresolved disputes, shall be resolved in the jurisdiction of Vijayawada.

**14. LIQUIDATION**

All the legal affairs of the society movable and immovable properties shall be settled under section 26 of the Societies Registration Act. In the District court.

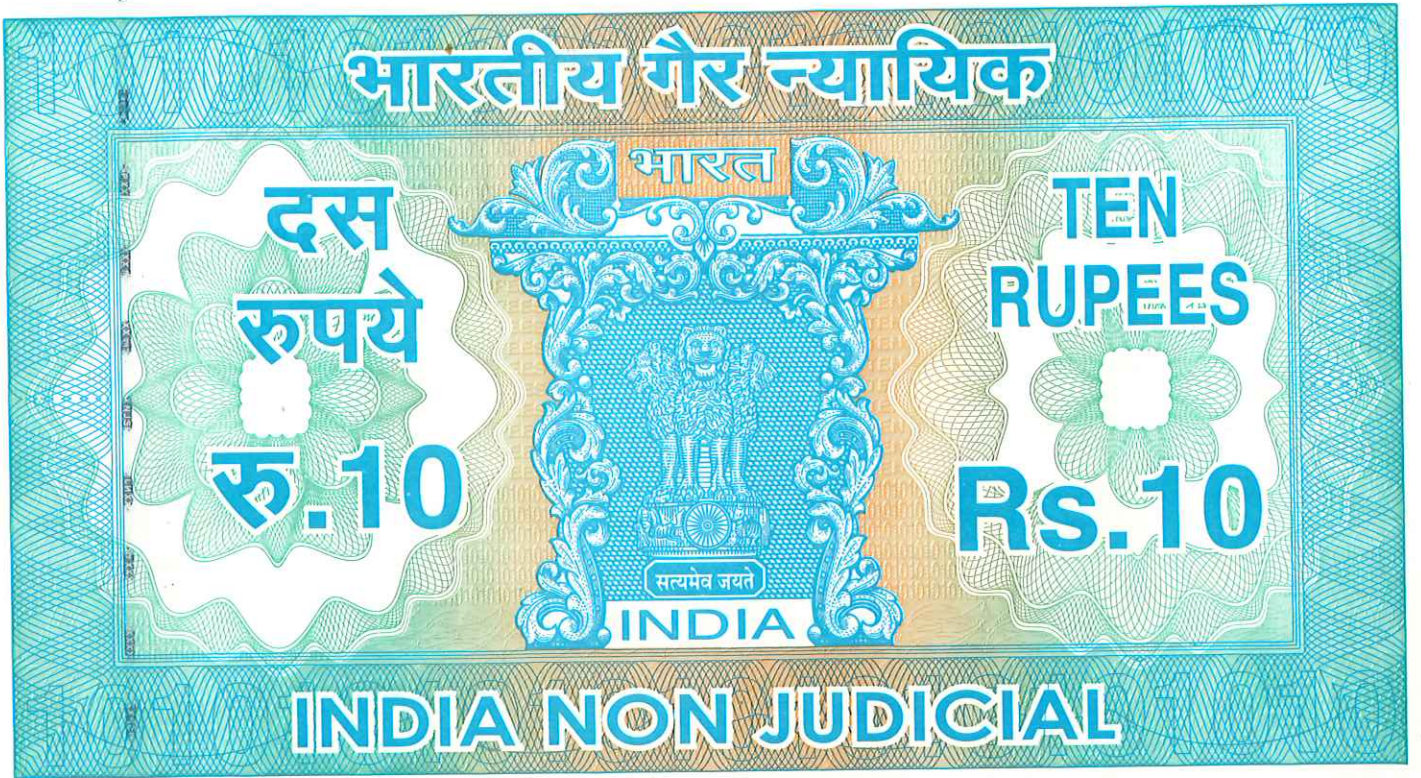

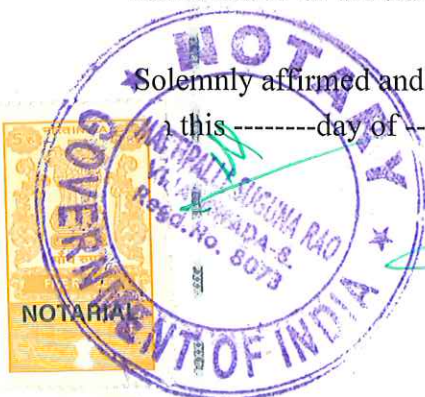
